## 2018 SDRS Legislation Passed

Four pieces of SDRS legislation were passed by both houses of the Legislature and signed into law by the Governor.

- SB 35: Revised the classification of juvenile corrections agents and certain terminology regarding correctional staff
- SB 36: Revised certain provisions relating to actuarial terminology, grievance procedures, refund qualifications, qualified domestic relations orders, supplemental pension benefits, and outdated references
- SB 37: Revised the automatic enrollment provisions of the SDRS Supplemental Retirement Plan (SRP)
- SB 38: Revised the process for establishing the compensation of the SDRS executive director
