## 2019 Legislation

The focus of the proposed legislation for the 2019 Legislative Session is to reorganize and move the SDRS statutes to a new chapter, most without any changes, and to clarify certain provisions in the process, including:

- Definitions, e.g. juvenile corrections agent revised
- Internal processes related to reports, applications, and stale checks
- Elected officials' irrevocable election to participate in SDRS
- Notarization for refunds
- Trustee position vacancy
- Additional contributions required for certain high-wage earners taking leave of absence
- Funding of Supplemental Pension Benefit with pre-tax dollars
