## 2021 Legislation Passed

Four pieces of SDRS legislation were passed by both houses of the Legislature and signed into law by the Governor.

- HB 1030: Revised and clarified certain provisions regarding the required minimum distribution methods of SDRS
- HB 1031: Revised certain provisions related to SDRS
- HB 1032: Revised the minimum cost of living adjustment (COLA) and revised SDRS terminology
- HB 1033: Updated certain provisions related to reemployment after retirement with SDRS
